P.L. 2007-80

AN ACT

to amend the Ministry of Justice Special Revenue Fund Act, 1989 (11 MIRC Ch.8) by removing
reference to work permits fees and charges.

BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS:

Section 1. **Short Title**

This Act may be cited as the Ministry of Justice Special Revenue Fund (Amendment) Act, 2007.

Section 2. **Amendment**

(1) Section 803(4)(d) of the Ministry of Justice Special Revenue Fund Act of 1989 is hereby
amended to read as follows:

§803. Payment into the Fund.

There shall be paid into the Fund:

- (1) any money appropriated by the Nitijela for the purposes of the Fund;
- (2) all fees, fines, and other sums paid to and collected by the courts for or
with respect to the violation of National Government laws, except such
sums as may be paid to Local Government Councils under the Judiciary
Fund Act of 1989 (27 MIRC 1A), and except as otherwise provided for
by any other Act; and
- (3) all grants, and gifts, received by the Ministry of Justice, other than money

1 appropriated by the Nitijela.

2 (4) all administrative fees and charges collected by the Office of the
3 Attorney-General, and all sub-divisions and agencies that are for the time
4 being responsible to the Office of the Attorney-General, and shall include
5 those fees and charges collected:

6 (a) for all passports;

7 (b) for citizenship matters;

8 (c) for all visas;

9 (d) for all documents and filings made pursuant to the provisions of
10 the Associations Law under 52 MIRC and any regulations
11 promulgated pursuant thereto.

13 **Section 3. Effective Date**

14 This Act shall take effect on the date of certification in accordance with the Constitution and
15 the Rules of Procedures of the Nitijela.




