## AN ACT

To amend the Finance Act 1974-1975.

(Certified: 22nd September, 1975)

Enacted by the Parliament of Nauru as follows:

### SHORT TITLE

1. This Act may be cited as the Finance (Amendment) Act 1974-1975.

### COMMENCEMENT

2. This Act shall be deemed to have come into operation on the thirtieth day of September, one thousand nine hundred and seventy-four.

### THE PRINCIPAL ACT

3. In this Act "the principal Act" means the Finance Act 1974-1975.

### AMENDMENT OF SECTION 2 OF THE PRINCIPAL ACT

4. Section 2 of the principal Act is amended by deleting the words, symbols, figures and punctuation "One million two hundred and twenty-nine thousand one hundred and sixty-six dollars (\$1,229,166)" in subsection (3) thereof and by inserting in lieu thereof the words, symbols, figures and punctuation "one million two hundred and sixty-two thousand four hundred and fifteen dollars (\$1,262,415)".

### REPEAL AND REPLACEMENT OF THE FOURTH SCHEDULE TO THE PRINCIPAL ACT

5. The Fourth Schedule to the principal Act is repealed and replaced by the following new Fourth Schedule—
