AN ACT

To provide for the withdrawal and expenditure of additional moneys from the Treasury Fund during the financial year ending on the Thirtieth day of June, One thousand nine hundred and eighty.

Enacted by the Parliament of Nauru as follows:

SHORT TITLE

1. This Act may be cited as the Supplementary Appropriation Act 1979-1980.

WITHDRAWAL OF MONEYS FROM THE TREASURY FUND

2. (1) The amount of Three million dollars (\$3,000,000) may be withdrawn from the Treasury Fund and expended as authorised in the Schedule to this Act in making a payment or payments to the Nauru Local Government Council of a sum by way of grant in aid of the establishment and development of the Nauru fishing industry.

(2) The amount authorised by this section to be withdrawn from the Treasury Fund and expended is additional to and not in substitution for the amounts authorised to be withdrawn from the Treasury Fund and expended by the Appropriation Act 1979-1980.
