INTERPRETATION ACT 1971

ORDER RECTIFYING CLERICAL ERROR IN WRITTEN LAW

IN EXERCISE of the powers conferred upon me by Section 70 of the Interpretation Act 1971, I hereby order that clerical errors in the Interpretation Act 1971 be rectified as follows, that is to say:

- (a) In subsection (1) of section 2 the words "and such territories of the British Commonwealth" are deleted.
- (b) In subsection (2) of section 10 the words "any applied statute is repugnant to or inconsistent with the provision of any other applied statute the provisions of" are inserted after the words, "where any provision of".
- (c) In paragraph (a) of subsection (1) of section 14 the word "at" is inserted after the words "at the time".
- (d) In section 57 the words "in the manner provided in the Criminal Code for the recovery" is inserted after the word "recovered".
