## THE CONSTITUTION OF NAURU

### PRESIDENTIAL APPOINTMENT

By virtue of the powers vested in me under Article 23 of the Constitution of Nauru, I, AUSTIN BERNICKE, ACTING PRESIDENT OF THE REPUBLIC OF NAURU, hereby assign -

1. To myself the business of Government in the following portfolios:
  - (a) The Portfolio of the Honourable the Minister for Health and Education
  - (b) The Portfolio of the Honourable the Minister for External Affairs
  - (c) The Portfolio of the Honourable the Minister for Internal Affairs.
2. To the Honourable the Minister for Justice, the business of Government in the Portfolio of the Honourable the Minister for Island Development and Industry.

The assignment of the Portfolios as listed above are made during the absence from the Republic of the Honourable Hammer DeRoburt, O.B.E., M.P.
