Position: Secretary for Finance

Salary: \$14,522 p.a. (fixed)

Duties: As head of the Department of Finance the Secretary for Finance is required to supervise revenue collection and the control of expenditure by all departments of the Republic government to ensure adequate recording of all financial transactions and to prepare periodic statements. He will be directly responsible for the administration of the Department of Finance and will advise the Minister for Finance and through him the Cabinet on all aspects of public finance. The Secretary for Finance is also responsible for the postal services of the Republic.

Qualifications: Ideally, applicants should possess a good honours degree in economics. A qualification in accounting and or a sound background in this field would be an added advantage. Candidates should have experience in government or quasi-government and in commercial finance, preferably internationally.
