EXPLOSIVES LICENCE

I, HAMMER DEROBURT, President of the Republic of Nauru, pursuant to Section 2 of the Explosives Ordinance 1924-1967 and Section 8 of the Licences Ordinance 1922-1967, do hereby licence

GENERAL MANAGER OF NAURU PHOSPHATE CORPORATION

or in his absence the person or persons acting for, on behalf, and with the authority of the said General Manager, to import and keep explosives in approved quantities: Provided that such explosives shall be safely and securely stored in a Magazine in the Fields Workshop area, of the said Corporation.

This licence shall remain in force from the 1st day of July, 1982 to the 30th day of June, 1983.
