APPOINTMENT OF CABINET UNDER ARTICLE 21

The portfolio of the Minister for Island Development and Industry in relation to the Business of Government to be undertaken by the said Minister.

The assignment of Business of Government of Nauru as set out above is in addition to and not in substitution for the Business of Government of Nauru already assigned to the said Ministers. The above assignments of responsibility for the Business of Government shall be effective during the absence from the Republic of His Excellency President Hammer DeRoburt, G.C.M.G., O.B.E., M.P.
