Those who disagree with the above determination of the Nauru Lands Committee may appeal to the Supreme Court within 21 days of the publication of this Gazette.

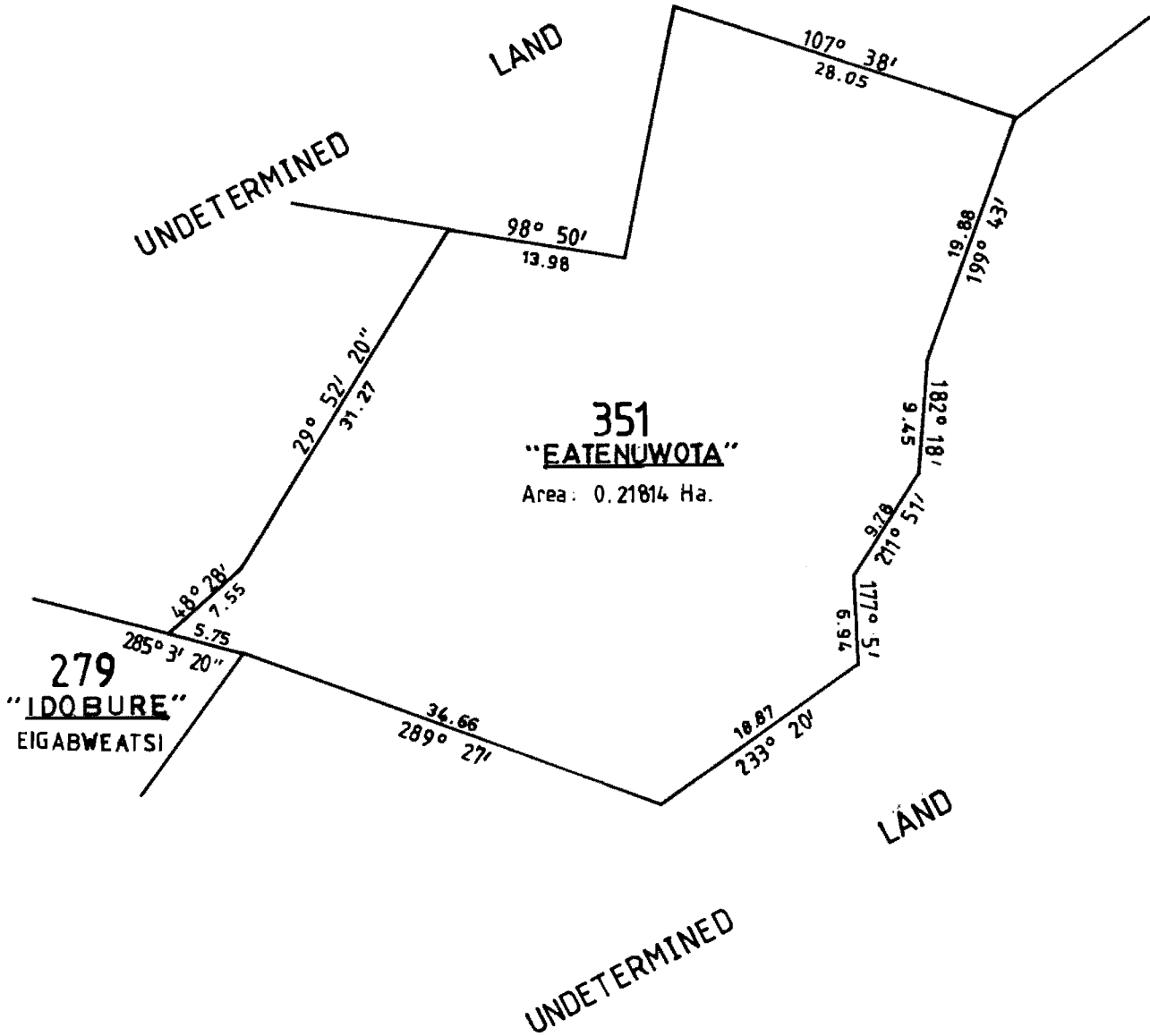

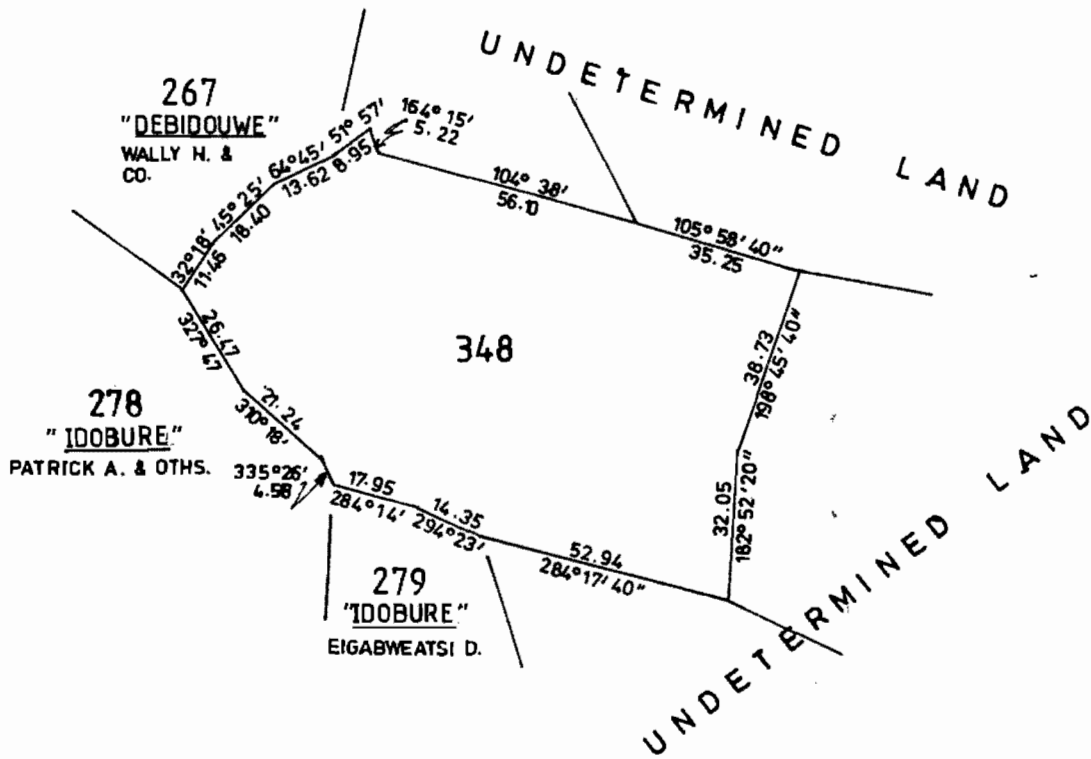
DISTRICT OF ANIBARE

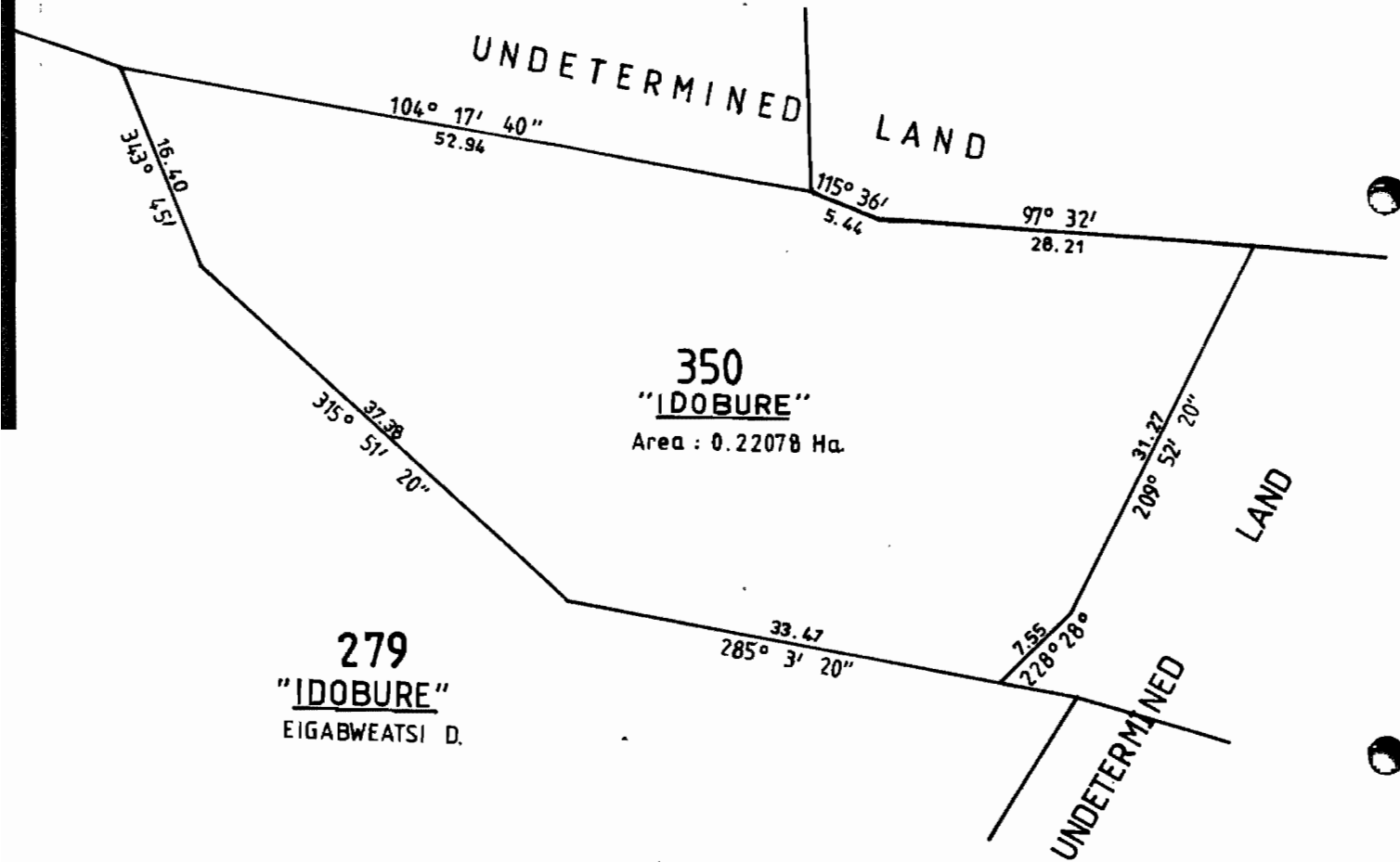

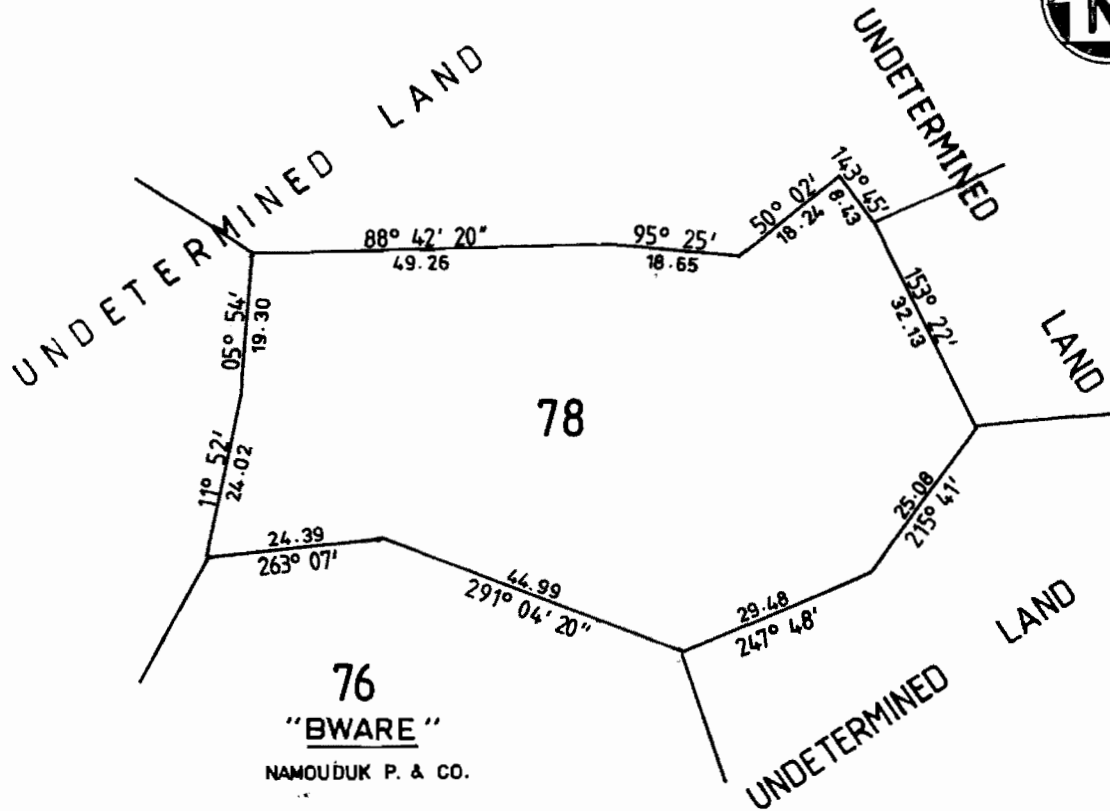
DISTRICT OF ANIBARE
