## CONSTITUTION OF NAURU APPOINTMENT OF CABINET UNDER ARTICLE 21

# CONSTITUTION OF NAURU ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF MAURU, I, HAMMER DEPOSURT, PRESIDENT OF THE REPUBLIC OF NAURU, SET OUT BELOW, THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE HIS NAME:

### MINISTER OF CABINET

#### BUSINESS OF COVERNMENT

HIS EXCELLENCY THE PRESIDENT

THE PORTFOLIO OF THE MINISTER
FOR WORKS AND COMMUNITY SERVICES
IN RELATION TO THE BUSINESS OF
GOVERNMENT TO BE UNDERTAKEN IN
NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION FOR THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTER. THE ABOVE ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF THE HONOURABLE BURARO DETUDAMO. M.P. MINISTER FOR WORKS AND COMMUNITY SERVICES.
