IT IS NOTIFIED for general information that Cabinet has, at its meeting held on 1st September, 1995, pursuant to Article 25, to Clause (1), Article 22 Clause (2), section 5, sub-section (2) approved the appointment of,

- (1) Pursuant to Article 25, Clause (1) of the Constitution of Nauru, appoint Mr. Creswick Agogenang, the substantive Secretary for Works & Community Services to act as Chief Secretary from 24th August, 1995 for the duration of absence of Mr. Kinza Clodumar from the Island.
- (2) Pursuant to Article 22, Clause 2 of the Constitution, appoint the said Mr. Agogenang to simultaneously act as Secretary to Cabinet for the said period;
- (3) Pursuant to Section 5, subsection (2) of the Births, Deaths and Marriages Ordinance 1957-1967, recognise the said Mr. Agogenang to be the Acting Registrar of Births, Deaths and Marriages during the said period.
