CONSTITUTION OF NAURU
ARTICLE 23

ASSIGNMENT OF RESPONSIBILITY FOR THE
BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, **KINZA CLODUMAR, M.P.**, PRESIDENT OF THE REPUBLIC OF NAURU, DO HEREBY, WITH IMMEDIATE EFFECT, ASSIGN TO THE MINISTERS NAMED BELOW, THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:-
