2. Private house in Aiwo goes to Ivy Dube for the duration of her life.
3. Ronwan to be distributed equally between Eva-Lilo Daniel 1/3, Dave Daniel 1/3 and Lutessa Daniel 1/3.
4. Sondan Daniel will be Trustee for Eva-Lilo, Dave and Lutessa Daniel until each reaches 18 years of age.
5. Overseas investment (Stock Exchange) granted to Sondan Daniel alone.

Those who disagree to the above determination may appeal to the Supreme Court Registry within 21 days of the publication of this Government gazette.
