PUBLIC NOTICE
BENEFICIAL OWNERSHIP ACT 2017

NOTICE is hereby given that pursuant to Section 9(1) of the *Beneficial Ownership Act 2017*, all corporations incorporated under the *Corporations Act 1972*, partnerships under the *Partnership Act 2018*, businesses registered in the name of 2 or more persons under the *Business Names Registration Act 2018* and express or implied trusts or unincorporated bodies operating in the Republic under an agreement or laws of the Republic, must keep a register of nominated officer(s) containing:

- (a) the officer's name;
- (b) the residential address of the officer(s) in Nauru; and
- (c) written confirmation of the officer's consent to the appointment.

The Authority (Secretary for Justice) grants all legal entities to which the *Beneficial Ownership Act 2017* applies **seven working days** from the date of this notice to comply with Section 9 of the Act, if not already done so.

A legal entity which fails to comply with Section 9 of the *Beneficial Ownership Act 2017* commits an offence and upon conviction, is liable to a fine not exceeding \$50,000.

Furthermore, under Section 33 of the *Beneficial Ownership Act 2017*, a legal entity may be struck off the relevant register or its registration may otherwise be cancelled where there is reasonable cause to believe that a legal entity has failed or is failing to comply with its obligation under the Act.
