Public Health Ordinances 1932.

WHEREAS by section 5 of the *Public Health Ordinances 1932*

(1) This notice dated 14.10.1932 and published in *N.G. Gaz.* of 17.10.1932 is printed as amended by two notices dated 25.1.1936 and 24.10.1939 and published respectively in *N.G. Gaz.* of 15.2.1936 and 31.10.1939. By notice dated 25.1.1936 and published in *N.G. Gaz.* of 15.2.1936 the Director of Public Health added at the end of the First Schedule to the notice dated 14.10.1932 and published in *N.G. Gaz.* of 17.10.1932 the words and figures "except township block No. 157." By notice dated 24.10.1939 and published in *N.G. Gaz.* of 31.10.1939 the Director of Public Health further amended the notice dated 14.10.1932 and published in *N.G. Gaz.* of 17.10.1932 "by omitting from the First Schedule to the notice the words and figures 'except township block No. 157' and inserting in their stead the words and figures 'except thereout township blocks Nos. 37 and 157.'"

HEALTH—

it is amongst other things provided that the Director may by notice in the *New Guinea Gazette* declare any portion of any town to be a residential area:

Now therefore I, Edward Thomas Brennan, the Director of Public Health of the Territory, do hereby declare the portions of the Town of Rabaul described in the Schedules hereto to be residential areas.

THE FIRST SCHEDULE.(1)

All that part of the Town of Rabaul(2) bounded on part of the south by that part of Park Street between Simpson Harbour and Mango Avenue thence on part of the east by that part of Mango Avenue between Park Street and the northern boundary of Section 46 thence on part of the north by the northern boundary of section 46 aforesaid and its production across a street 10 metres wide and by a northern boundary of section 47 thence again on the east by an eastern boundary of section 47 aforesaid and its production north across a street and by the generally western boundary of the Botanic Reserve(3) thence again on the north by a line parallel to Malaguna Road from the westernmost corner of the Botanic Reserve to the north-western boundary of the said Town near Rataval Tunnel thence on the north-west by part of the Town boundary(2) south-westerly to Rataval Road thence on the south-west by Rataval Road aforesaid south-easterly to Malaguna Road thence again on the south by Malaguna Road aforesaid east to Baluan Street thence on the west by Baluan Street aforesaid south to Simpson Harbour thence again on the south-west by the shore of Simpson Harbour south-easterly to Park Street aforesaid excepting thereout township blocks Nos. 37 and 157.(1)

THE SECOND SCHEDULE.

All that part of the Town of Rabaul bounded on part of the west by that part of Yara Avenue between Court Street and the northern boundary of Portion 145 known as Matupi Farm thence on part of the north by that part of the northern boundary of Portion 145 aforesaid between Yara Avenue and Sulphur Creek Road thence again on the west and generally on the south by Sulphur Creek Road aforesaid southerly and generally easterly to Rapindik Road thence on part of the west by Rapindik Road north to the northern boundary of Matupi Farm aforesaid thence on the south by part of the northern boundary of Matupi Farm and its production east to the eastern boundary of the said Town thence generally on the south-east again on the south and again on the east by the Town boundary(2) thence on the north-east by the Town boundary(2) north-westerly to the eastern boundary of the Botanic Reserve(3) aforesaid thence again on the west by the eastern boundary of the Botanic Reserve(3) aforesaid generally southerly to the south-east corner of the said Botanic Reserve(3) thence, again on the north by part of the Southern boundary of the said Botanic Reserve(3) west for approximately 350 metres thence again on the west by a line south to its intersection with a production west of the northern boundary of section 3 thence again on the north by a line being the said production of the northern boundary
