Being an Act to amend the *Classification of Publication (Censorship) Act* 1989 to remove powers to impose fees and charges, and for related purposes,

MADE by the National Parliament to come into operation in accordance with a notice in the National Gazette by the Head of State, acting with, and in accordance with, the advice of the Minister.

1. APPLICATION FOR REGISTRATION OF PREMISES (AMENDMENT OF SECTION 28).

Section 28 of the Principal Act is amended in Subsection (2), Paragraph (c), by deleting the word "prescribed".

- 2. CHANGE OF PUBLICATION PREMISES (AMENDMENT OF SECTION 31). Section 31 of the Principal Act is amended in Subsection (2), Paragraph (*c*), by deleting the word "prescribed".
- 3. CONSIDERATION OF DECLARED PUBLICATION FOR CLASSIFICATION (AMENDMENT OF SECTION 38).

Section 38 of the Principal Act is amended in Subsection (2), Paragraph (c), Subparagraph (i), by deleting the word "prescribed".
