Town Planning Act (Chapter 204)

NOTIFICATION OF ZONING OF TOWNS

GENERAL PRICES (AMENDMENT No. 28) ORDER 1983

being

A Prices Order to amend General Prices Order 1983.

MADE by the Deputy Price Controller under the *Prices Regulations Act* (Chapter 320), to come into operation on the 1st day of January, 1984.

AMENDMENT TO SCHEDULE 10.

Schedule 10, which relates to maximum electricity charges, is amended by adding after clause D the following clauses:

'E. INDUSTRIAL RATES

All energy	8.0 toea per kwh
Demand charge	K11.00 per kva
Minimum demand charge	K2 200.00 per month

The above rates are applicable to large industrial and commercial consumers with a demand of approximately 200 kva or more in the centres of: Port Moresby, Goroka, Kainantu, Kieta/Arawa, Lae, Madang, Mt Hagen, Rabaul and Yonki.

F. STAND-BY CHARGES

Where electricity is supplied by the Electricity Commission to an installation that is supplied by electricity from a source other than the Commission supply, the Commission may impose, in addition to the charge for electricity consumed by the installation, a stand-by charge not exceeding 50% of the difference between the amount paid by the consumers in respect of an accounting period and the amount that would have been paid if electricity not supplied by the Commission during that period had been supplied by the Commission. In special circumstances, this charge may be waived or reduced on application.
