## ABOLITION OF DEPARTMENTS, OFFICE OF DEPARTMENTAL HEAD AND ESTABLISHMENT OF DEPARTMENTS AND CREATION OF OFFICES OF DEPARTMENTAL HEAD

I, Kingsford Dibela, G.C.M.G., K St. J., Governor-General, by virtue of the powers conferred by the *Public Services (Management) Act 1986* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby—

- (a) in accordance with Section 19(2)(b) of the Act, abolish the following Departments:—
  - (i) Department of Civil Aviation, Culture and Tourism; and
  - (ii) Department of Finance; and
  - (iii) Department of Treasury; and
- (b) in accordance with Section 21(b) of the Act, abolish the following offices of Departmental Heads:—
  - (i) the Office of the Departmental Head of the Department of Civil Aviation, Culture and Tourism; and
  - (ii) the Office of the Departmental Head of the Department of Finance; and
  - (iii) the Office of the Departmental Head of the Department of Treasury; and
- (c) in accordance with Section 19(2)(a) of the Act, establish the following Departments:—
  - (i) Department of Civil Aviation; and
  - (ii) Department of Culture and Tourism; and
  - (iii) Department of Finance and Planning; and
- (d) in accordance with Section 21(a) of the Act, create the following offices of Departmental Head:—
  - (i) the Office of Departmental Head of the Department of Civil Aviation; and
  - (ii) the Office of Departmental Head of the Department of Culture and Tourism; and
  - (iii) the Office of Departmental Head of the Department of Finance and Planning.

## AMENDMENT OF DETERMINATION OF FUNCTIONS OF DEPARTMENTS
