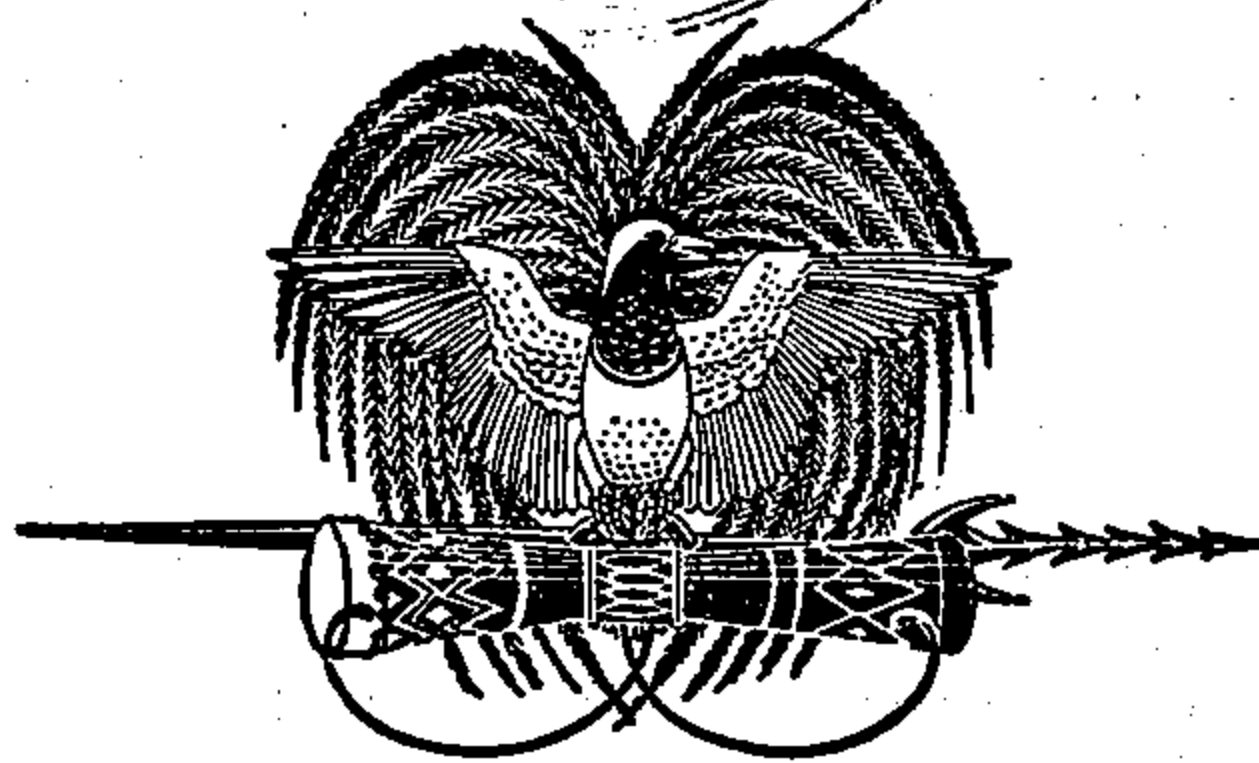

Organic Law on National Elections (Amendment) 1991

Being a Law to alter the Organic Law on National Elections—

(a) as incidental to the making in 1979 of the Organic Law on Provincial Boundaries (Amendment No. 1) Law which effected changes to the Provincial Boundaries of the Western Highlands and Manus Provinces; and

(b) to make special provision for the inhabitants of the Lumusa Census Division in the Western Highlands Province and Aua and Wuvulu Islands Census Division in the Manus Province who have been affected by those changes to participate meaningfully in the national elections,

MADE by the National Parliament.

1. PROVINCIAL BOUNDARIES (AMENDMENT OF SECTION 33).

Section 33 of the Organic Law on National Elections is amended by inserting at the end thereof the following subsection—

"(4) Notwithstanding anything in subsection (3) but subject to any change, by law or resolution of the Parliament, in the terms of office of members of the Parliament holding office after the general elections in 1987—

(a) the inhabitants of the Lumusa Census Division in the Western Highlands Province; and

(b) the inhabitants of the Aua and Wuvulu Islands Census Division in the Manus Province,

whose areas were included in the Western Highlands and Manus Provinces respectively by the Organic Law on Provincial Boundaries (Amendment No. 1) Law in 1979 shall, for the purposes of this law and the general elections scheduled to be held in 1992, and all other elections following, participate in—

(c) in the case of the inhabitants of the Lumusa Census Division—the provincial electorate of Western Highlands; and

(d) in the case of the inhabitants of the Aua and Wuvulu Islands Census Division—the provincial electorate of Manus

respectively."

2. NEW SECTION

The Organic Law on National Elections is amended by adding after section 35 the following new Section—

"35A. Special case provision.

Notwithstanding anything in this Law but subject only to the determination from time to time of open electorates by the Parliament in accordance with section 125 (electorates and boundaries) of the Constitution and the provisions of this Law, and any change that may be made by law or resolution of the Parliament to the terms of office of the members of the Parliament holding office after the general elections in 1987,—

(a) the inhabitants of the Lumusa Census Division in the Western Highlands Province; and

(b) the inhabitants of the Aua and Wuvulu Islands Census Division in the Manus Province,

whose areas were included in the Western Highlands and Manus Provinces respectively by the Organic Law on Provincial Boundaries (Amendment No. 1) Law in 1979 shall, for the purposes of this law and the general elections scheduled to be held in 1992, and all other elections following, participate in—

(c) in the case of the inhabitants of the Lumusa Census Division—the Baiyer-Mul open electorate; and

(d) in the case of the inhabitants of the Aua and Wuvulu Islands Census Division—the Manus open electorate respectively as last determined by the Parliament."

Physical Planning Act (No. 32 of 1989)

NOTIFICATION OF ZONING OF PHYSICAL PLANNING AREAS

THE PAPUA NEW GUINEA NATIONAL PHYSICAL PLANNING BOARD, by virtue of the powers conferred by Section 71 of the *Physical Planning Act* (No. 32 of 1989) of the Revised Laws of Papua New Guinea, and all other powers it enabling, hereby gives notice of the zoning of physical planning areas specified in the Schedule hereto.
