

I, Titus Philemon, Parliamentary Secretary to the Minister for Finance and Planning, by virtue of the powers delegated to me under Section 39 of the *Public Finances (Management) Act 1986* and all other powers me enabling, acting on the advice of the Departmental Head of the Department responsible for financial management hereby:—
