Public Services (Management) Act 1995

REVOCATION AND APPOINTMENT AND OF ACTING APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEADS

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(1) of the Constitution and Sections 25, 26, 27 and 31 of the *Public Services (Management) Act 1995*, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Services Commission hereby:—

- (a) revoke the appointment of Noel Levi as Secretary, Department of Prime Minister and National Executive Council; and
- (b) revoke the appointment of Robert Igara as Acting Secretary, Department of Prime Minister and National Executive Council; and
- (c) appoint Robert Igara to be Departmental Head, Department of Prime Minister and National Executive Council for a period of four years,

with effect on and from the date of publication of this instrument in the *National Gazette*.
