1. that PNG Bottles Industries Limited may be wound up by the court under the provisions of the *Companies Act*;

3. that the bank in which the liquidator is to be open a trust account be the ANZ Banking Group (PNG) Limited, Port Moresby branch;
4. that the liquidator pay the petitioner's costs of and incidental to the petition to be taxed on a common fund basis; and
5. that leave be given to abridged time for entry of this order to the time of settlement by the Registrar which shall take place forthwith.

**EXEMPTION UNDER SECTION 136**

PURSUANT to Section 136 of the *Securities Act 1997* the Securities Commission of Papua New Guinea ("the Commission") from the date of this notice hereby exempts Kina Securities Limited from compliance with the requirements of Section 19 of the *Securities Act 1997* in relation to the conduct by it of a market in securities which are not listed on an approved stock exchange ("the market facility"), on the conditions that—

1. the market facility does not consist of regular trading activity, and in particular, not more than 50 completed transactions are made through the market facility in any 12 month period;
2. there is no reasonable expectation from buyers and sellers that they will be able to sell, purchase or exchange securities on a regular basis;

**Exemption Under Section 136—continued**

3. the total value of the transactions made through the market facility do not exceed K500 000 in any 12 month period; and
4. the market facility is for unlisted shares only and is not used to trade securities listed on an approved stock exchange;
5. Kina Securities Limited is at all times a member of an approved stock exchange;
6. Kina Securities Limited, its employees and agents in the course of conducting the market facility, do not engage in any conduct, or do any Act or omission which would breach Section 55(2) of the *Securities Act 1997*;
7. Kina Securities Limited, its employees and agents do not hold funds or securities relating to transactions arising from the operation of the market facility;
8. Kina Securities Limited provides to the Commission on 1st March of each year, or more often if required by the Commission, a report in writing detailing the name of the company to which each transaction relates, and the number and value of each transaction made through the market facility; and
9. the Commission may amend or revoke this exemption at any time, at its own discretion.

**Interpretation**

"approved stock exchange" has the same meaning as in Section 2 of the *Securities Act 1997*;

**EXEMPTION UNDER SECTION 136**
