REDUCTION OF IMPORT DUTIES IN RESPECT OF CERTAIN GOODS IMPORTED FROM FIJI

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, with effect on and from the date of publication of this instrument in the *National Gazette* reduce the import duty rate on goods specified in Column 2 of the Schedule from the Current Tariff Rate to the rate specified in Column 3 of the Schedule where such goods:—

- (a) are imported from the Republic of Fiji; and
- (b) originate in the country from which they are imported in accordance with the Rules of Origin (ROO) set in Annex to Schedule 1 to the Trade Agreement between PNG and Fiji Islands.



REDUCTION OF IMPORT DUTIES IN RESPECT OF CERTAIN GOODS IMPORTED FROM MSG COUNTRIES (FIJI, SOLOMON ISLANDS AND VANUATU).

I, SILAS ATOPARE, G. C. M. G., K. St. J., Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the *Customs Tariff Acts 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, with effect on and from the date of publication of this instrument in the National Gazette reduce the import duty rate on goods specified in column 3 of the Schedule from the Current Tariff Rate to the rate specified in Column 5 of the Schedule where such goods –

- (a) are imported from the Republic of Fiji, Solomon Islands and the Republic of Vanuatu and
- (b) originate in the country from which they are imported in accordance with the Rules of Origin set in the Annex to Schedule 1 of the Trade Agreement amongst the MSG countries.


