*Forestry Act 1991***INSTRUMENT OF APPOINTMENT OF FOREST OFFICERS AND FOREST INSPECTORS**

I, Michael Ogio CMG, C.B.E., M.P., Minister for Forests, by virtue of the powers conferred by Section 41(1) & (2) of the *Forestry Act 1991*, and after having received a recommendation from the Board of the Forest Authority so to do and all other powers me enabling, do hereby:—

- (1) revoke all appointments of Forest Officers and Forest Inspectors at any time hereinbefore made; and
- (2) appoint those officers of the National Forest Service specified in Attachment "A" as Forest Officers such said officers having obtained the degree or diploma of a recognized forestry school and further appoint such said officers as Forest Inspectors; and
- (3) appoint those officers of the National Forest Service specified in Attachment "B" hereto as Forest Inspectors.
