1. This Ordinance shall be entitled the Choiseul Province
1993 -1994 Appropriation Ordinance 1993 and shall come into force
upon approval of the Minister in accordance with Section 32 of the
Provincial Government Act 1981 and publication in the Solomon
Islands Gazette.

Authorisation
of issue of

2. The appropriation from the Provincial Fund is hereby authorised of a sum of THREE MILLION SIX HUNDRED AND EIGHTY THOUSAND FIVE HUNDRED AND TEN DOLLARS to be applied for purposes specified in Section 36(2) of the Provincial Government Act, and to the services of the financial year ending 31st March, 1994.

Appropriation.

3. The sum specified in the preceding Section shall be appropriated for the supply of the heads specified, and in the amounts respectively specified in relation thereto in the schedule to this Ordinance.

Contingencies
Warrants.

4. The total of the sums authorised by contingencies warrants issued by the Premier in exercise of his powers under section 26 and 27 of the Choiseul Province Financial Management Ordinance 1992 for the financial year ending 31 March, 1994 shall not exceed:

- (a) in respect of Heads of Recurrent Expenditure Thirty Thousand dollars;
- (b) in respect of Heads of Capital Expenditure Twenty Thousand dollars.

Advances.

5. The total of the sums authorised by advances warrants issued by the Premier in exercise of his powers under section 43 of the Choiseul Province Financial Management Ordinance 1992 for the financial year ending 31 March, 1994 shall not at anytime exceed Ten Thousand dollars.
