**AN ORDINANCE TO AMEND THE ISABEL PROVINCE
BUSINESS LICENCE ORDINANCE 1994.**

ARRANGEMENT OF SECTIONS

1. This Ordinance may be cited as the Isabel Province Business Licence (Amendment) Ordinance 1995 and shall come into operation after assent by the Minister of Provincial Government and upon publication in the Solomon Islands Gazette.

2. The part of arrangement of sections - schedules to the Isabel Province Business Licence Ordinance 1995 entitled "6. Application for transfer of licence" is hereby deleted and substituted therefore the description "6. Conditions relating to botany, marine products, marine resource sales".

3. The Isabel Province Business Licence Ordinance 1994 is amended:

(1) by repeal of section 6(2) and substituting therefore "in addition to any conditions which may be imposed under section 5(3) hereof, (i) money lending licences shall include conditions set out in schedule 5 hereof and (ii) botany marine resources sales and wildlife collecting licences shall include conditions as set out in schedule 6 hereof".

(2) by amendment of section 6(7) by deleting the words "forms 1 schedule 1" where they occur and substituting therefor the words "schedule 7".

Schedule 3 to the Isabel Province Business Licence Ordinance 1994 is hereby repealed and the following new schedule 3 substituted therefor.
