THE MALAITA PROVINCE 1994-1995 APPROPRIATION ORDINANCE 1994

AN Ordinance to appropriate Eight Million, Three Hundred and Forty-Six Thousand Four Hundred and Twenty-Two dollars to the service of the financial year ending 31st March 1995.

ENACTED by the Malaita Provincial Assembly with the assent of the Minister as follows -

Short Title and Commencement. 1. This Ordinance shall be entitle the Malaita Province Appropriation Ordinance 1994 and shall come into force upon approval by the Minister in accordance with Section 32 of the Provincial Government Act 1981 and publication in the Solomon Islands Gazette.

Authorisation of issue of \$8,346,422 2. The Appropriation from the Provincial Fund is hereby authorized of the sum of eight million, three hundred forty-six thousand four hundred twenty-two dollars to be applied for the purpose specified in section 36(2) of the P.G.A., and to the service of the fiscal year ending 31 March 1995.

Appropriation. 3. The sum specified in the preceeding section shall be appropriated for the supply of the Heads specified and in the amounts respectively in relation thereto, in the Schedule to this Ordinance.

Contingencies Warrants. 4. The total of the sums authorized by Contingencies Warrants issued by the Premier in exercise of his powers under Section 26 of the Malaita Province Financial Management Ordinance 1991 for the Financial Year ending 31 March 1995 shall not exceed -

- (a) in respect of Heads of Recurrent Expenditure nine hundred thousand dollars.
- (b) in respect of Heads of Capital Expenditure four hundred thousand dollars.

5. The total of the sums authorised by Advances Warrants issued by the Premier in exercise of his powers under Section 43 of the Malaita Province Financial Ordinance 1991 for the Financial Year ending 31st March 1995 shall not at any time exceed one hundred thousand dollars.

6. The Overdraft and other borrowing of Malaita Province shall not at any time exceed one hundred thousand dollars during the Financial Year ending 31 March 1995.
