**PRICE CONTROL ACT
(Cap. 64)****THE PRICE CONTROL (APPLICATION TO GOODS
AND RESTRICTION OF PRICES) AMENDMENT
(NO. 3) ORDER 2002**

IN exercise of the powers conferred by section 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, EDWARD HUNUEHU Minister of Commerce, Employment and Trade, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) No. 3) Order 2002 and shall come into operation on 25 June 2002.
2. Schedules 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987* is hereby amended by deleting serial No. 12 thereof and substituting therefor the following -

“12 LIQUID PETROLEUM GAS

	WHOLESALES (maximum price per kilogram)	RETAIL (maximum price per kilogram)
(a) Butane gas	\$7.32	\$9.16
(b) Propane Gas	\$7.32	\$9.16”

(Cap. 121)

THE CUSTOMS AND EXCISE (DUTIES) (AMENDMENT)
(NO. 7) ORDER 2002.

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, LAURIE CHAN, Minister of Finance, do hereby make the following Order:-

1. This Order may be cited as the Customs and Excise (Duties) Amendment) (No. 7) Order 2002 and shall come into effect on the date of publication in the Gazette.

2. That part of the First Schedule to the Customs and Excise Act entitled "EXCISE CLASSIFICATION AND TARRIF" is hereby amended in the following respects:-

- (a) by deleting tariff item number "E.1" and duty rate of \$40.00 per kg and substituting therefor tariff item number "E.1(a)" and duty rate of \$40.00 per kg.
- (b) by deleting tariff item number "E.1.1." and duty rate of "\$.35 per stick" and substituting therefor tariff item number "E.I (b)" and duty rate of "\$0.30 per stick".
- (c) by deleting "E.11.2" and duty rate of "\$420.00 per kg" a and substituting therefor "E1 (c)" and duty rate of "\$360.00 per kg" respectively.

**THE CUSTOMS AND EXCISE (DUTIES) (AMENDMENT)
(NO. 8) ORDER 2002**

In exercise of the powers conferred by section 7 of the Customs and Excise Act, I, LAURIE CHAN, Minister of Finance, do hereby make the following Order:-

1. This Order may be cited as the Customs and Excise (Duties) (Amendment) (No. 8) Order 2002 and shall come into force on the date of publication in the gazette.
2. That part of the First Schedule to the Customs and Excise Act entitle "IMPORT CLASSIFICATION AND TARIFF" is hereby amended in the following respects:-
 - (a) by deleting the duty rate of \$600.00 per kg in respect of tariff item numbers 2402.1000, 2403,9100 and 2403.9900 and substituting therefor duty rate of "\$500.00 per kg".
 - (b) by deleting the duty rate of "\$0.50 per stick" in respect of tariff item numbers 2402.2010, 2402.2020 and 2402.9000 and substituting therefor duty rate of "\$0.42 per stick".
 - (c) by deleting the duty rate of "\$180.00 per kg" in respect of tariff item number 2403.1090 and substituting therefor duty rate of "\$500.00 per kg".

**THE FISHERIES ACT 1998
(NO. 6 of 1998)**

**THE FISHERIES TRAWLING OR DREDGING
PROHIBITION REGULATION 2002**

IN exercise of the powers conferred by section 59 of the Fisheries Act 1998, I, NELSON KILE, Minister of Fisheries and Marine Resources, do hereby make the following regulation:-

- Citation
1. This Regulation may be cited as the Fisheries Trawling or Dredging Prohibition Regulation 2002.
 2. Any person who uses bottom trawling or d

redging method for the purpose of harvesting sedentary and other ethnic resources, shall be guilty of an offence and shall on conviction be liable to a fine not less than five thousand dollars or to six months imprisonment or to both such fine and imprisonment.
