**PRICE CONTROL ACT  
(Cap. 64)****THE PRICE CONTROL (APPLICATION TO GOODS AND  
RESTRICTION OF PRICES) (AMENDMENT) (NO.8) ORDER 2004**

IN exercise of the powers conferred by sections 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, WALTON NAEZON, Minister of Commerce, Employment and Trade, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No.8) Order 2004 and shall come into operation on 14 October 2004.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987\* is hereby amended by deleting serial No.13 thereof and substituting therefor the following -

**"12 LIQUID PETROLEUM GAS**

(a) Butane Gas	10.95	13.68
(b) Propane Gas	10.95	13.68"

(Cap. 123)**

**THE INCOME TAX (EXEMPTION OF TAX) (INCOME DERIVED  
UNDER GOOD GOVERNANCE IN IMPLEMENTATION OF THE  
SOLOMON ISLANDS LEGISLATIVE PROGRAM OF ACTION)  
ORDER 2004**

IN exercise of the powers conferred upon me by section 16(2) of the Income Tax Act, the following Order is hereby made -

1. This Order may be cited as the Income Tax (Exemption of Tax) (Income Derived Under Good Governance in Implementation of the Solomon Islands Legislative Program of Action) Order 2004.

2. The emoluments paid to an employee of the Solomon Islands Government under the aforesaid Program shall be exempt from tax for a period of two years commencing from 10 December 2003.
