PUBLIC SERVICE ACT
(Cap. 92)**Public Service (Overseas Service) (Amendment) Rules 2008**

IN exercise of the powers conferred upon me by section 4 of the Act and after consulting the Commission, I make these Rules –

Citation

1. These Rules may be cited as the Public Service (Overseas Service) (Amendment) Rules 2008.

Rule 8(2)
amended

2. The Public Service (Overseas Service) Rules are amended in rule 8 –

(a) in subparagraphs by adding the following paragraphs –

- “(ba) appointment grant allowance;
- (bb) domestic servant allowance, which shall be payable only for domestic servant engaged from Solomon Islands;
- (cc) hard posting allowance which shall be payable only to diplomat or officers working in high risk countries or dangerous places;”;

(b) by adding the following paragraph –

“(2A) A non-resident ambassador, high commissioner or consulate general is entitled to appointment grants, clothing allowances (not applicable to spouse and children), representation allowances and domestic servants allowances applicable to a resident ambassador, high commissioner or consulate general at the rate set out in the Schedule.”.

3. The Public Service (Overseas Service) Rules are amended by revoking the Schedule and substituting the following Schedule –
