(NO.7 of 1997)****THE CHOISEUL PROVINCE BUSINESS LICENCE ORDINANCE 1993****THE CHOISEUL PROVINCE BUSINESS LICENCE (AMENDMENT)
REGULATIONS 2010**

Made by the Choiseul Provincial Assembly on the 25th day of May 2010.

IN exercise of the powers conferred by sections 9 and 15 of the Choiseul Province Business Licence Ordinance 1993, the Choiseul Provincial Assembly makes the following Regulations –

1. These regulations may be cited as the Choiseul Province Business Licence (Amendment) Regulations 2010, and shall come into force on the date that they are passed by the Choiseul Provincial Assembly.

2. Schedule 8 of the Choiseul Province Business Licence Regulations 2008 is hereby amended by adding a new Prescribed Business of “Telecommunications Service” with an Annual Business Licence Fee of “\$10,000, plus \$8,000 for each operational transmission tower”.

Passed by the Choiseul Provincial Assembly this 25th day of May 2010.

**THE CHOISEUL PROVINCE
BUSINESS LICENCE REGULATIONS (COMMENCEMENT)
ORDINANCE 2010**

AN ORDINANCE TO VALIDATE AND CONFIRM ALL ACTS DONE IN GOOD FAITH BETWEEN THIS 22ND OF JANUARY 2009, AND THE COMMENCEMENT OF THIS ORDINANCE IN THE PURPORTED EXERCISE OF THE JURISDICTION CONFERRED ON CERTAIN PERSONS UNDER THE CHOISEUL PROVINCE BUSINESS LICENCE REGULATIONS 2008.

Enacted by the Choiseul Provincial Assembly

WHEREAS:

- A. The Choiseul Province Business Licence Regulations 2008 were approved by the Choiseul Provincial Assembly on the 22nd of January 2009;
- B. The Choiseul Provincial Government enforced the said Regulations on the understanding that they were in force;
- C. The said Regulations were to have come into force on the date of their being published in the *Gazette*, however they have not been published in the *Gazette*;
- D. The Province believes that no-one has been prejudiced by the failure to *Gazette* the Regulations; and
- E. It is desirable to validate and confirm all acts done in good faith by the Choiseul Provincial Government in the purported exercise of certain functions and powers conferred upon it by the said Regulations.

THEREFORE:

1. This Ordinance may be cited as the Choiseul Province Business Licence Regulations (Commencement) Ordinance 2010 and shall come into effect on the date it is assented to by the Minister in accordance with section 30 of the Provincial Government Act 1997. Short Title
2. In this Ordinance, except where the context otherwise requires: Interpretation
- “Executive” means the Choiseul Provincial Executive
- “Regulations” means the Choiseul Province Business Licence Regulations 2008
3. Notwithstanding section 1 of the Choiseul Province Business Licence Regulations 2008, the Regulations are hereby deemed to have come into force and effect as of the 22nd of January 2009, therefore: Validation and Indemnity
- (1) All acts done in good faith between the 22nd of January 2009 and the commencement of this Ordinance, by any persons in the purported exercise of the jurisdiction and powers conferred upon, and vested in them, under the Regulations, are hereby declared to have been validly, properly and lawfully done and are hereby confirmed;
- (2) All fees purportedly imposed under the Regulations between the 22nd of January 2009 and the commencement of this Ordinance are hereby deemed to have been validly imposed;
- (3) The Regulations will continue in force from the commencement of this Ordinance.
4. (1) Any person who claims to have been prejudiced by the failure to publish the Regulations in the Gazette between the 22nd of January 2009 and the commencement of this Ordinance may apply to the Executive for a refund or waiver of all or part of the different between the licence fees payable under the Regulations and those payable under the previous regulations for that period. Right to Seek Waiver of Fee
- (2) The Executive shall, if it determines that there has been prejudice, grant such waiver or refund in an amount set by the Executive based on the nature and extent of the prejudice.

No Criminal
Proceedings

5. No Criminal Proceedings shall be issued for a failure to pay the licence fees set out in the Regulations during the period between the 22nd of January 2009 and the commencement of this Ordinance, however if any business has operated in Choiseul without a licence or without paying the full licence fee due each year under the Regulations during that period, the amount that would have been due as a business licence fee under the Regulations for that period, or such portion of it as remains unpaid, together with interest in accordance with section 9A of the Choiseul Province Business Licence Ordinance, shall be due and owing to the Choiseul Provincial Government as a civil debt.
