**THE WILDLIFE PROTECTION AND MANAGEMENT ACT 1998  
(NO. 10 OF 1998)**

**The Wildlife Protection and Management Order 2014**

IN exercise of the powers conferred under section 34 of the Act, I, Bradley Tovosia, Minister for Environment, Climate Change, Disaster Management and Meteorology, do hereby make this Order.

1. This Order may be cited as the Wildlife Protection and Management Order 2014 and shall commence on the date of publication in the *Gazette*.
2. Schedules 1 and 2 of the Wildlife Protection and Management Act 1998 are hereby amended by deleting the word "Xanthostermon SP" that appears under heading PLANTS in Schedule 1 and inserting the word "Xanthostermon SP" under the heading PLANTS in proper alphabetical order as it appears under Schedule II therein.

**DEPORTATION ACT  
(CAP. 58)**

**DEPORTATION ORDER – STATEMENT OF FACTS**

**WHEREAS YOU, JOHN KEITH HUTTON**, a person who was issued a resident permit NO: 1063/10 under section 8 (1) of the *Immigration Act* (Cap. 60) by the Director of Immigration.

**WHEREAS** the Director of Immigration has cancelled your resident permit on the 17th day of December, 2013, and your continuing presence in Solomon contravenes section 11(1) as read with section 6(2) of the *Immigration Act* (Cap. 60).

**AND WHEREAS** the Director of Immigration has cancelled your resident permit consequently on the 17th of December 2013 with the Commissioner of Labour's cancellation of the work permit.

**AND WHEREAS YOU** have conducted yourself in a manner prejudicial to peace and public order in Solomon Islands and have thus declared by the Government as an undesirable immigrant under section 11(2)(f) of the *Immigration Act* (Cap. 60).

**AND TAKE NOTICE** that the particulars of the facts against you, **John Keith Hutton** or upon which this ORDER is made are as follows –

1. That you are a foreign national from New Zealand.
2. That you entered the country under the resident permit Imm F: 1063/10 to reside and work under Padani Construction, Gizo, Western Province and your work permit was cancelled by the Commissioner of Labor on the 21st November 2013 upon the request from the company management.
3. Director of Immigration has cancelled your resident permit on the 17th December 2013, consequently resulting in the cancellation of your work permit.
4. That you have paid a fine of \$4,802.82 to the Solomon Islands government GTR NO: B1230280 for false declaration of goods under Solomon Islands Customs & Excise Act.

**NOW THEREFORE** pursuant to section 4 of the *Deportation Act* (Cap. 58) as read with section 5(1) of the same Act and having regard to the particulars stated above, I hereby order you, **John Keith Hutton**, to leave and thereafter and stay out of Solomon Islands.

**AND** pursuant to section 7(2) of the *Deportation Act* (Cap. 58), I hereby authorize this Order is served on **John Keith Hutton** to place him on board any ship or aircraft leaving Solomon Islands.

**AND** I further authorize and direct the Officer-In-Charge of the Honiara Rove Correctional Service or Honiara Police Stations in Solomon Islands to detain the said **John Keith Hutton** until arrangements are completed before placing him on board any ship or aircraft.
