NOTICE OF MAKING RULES BY ADOPTION (SOLOMON ISLANDS CIVIL AVIATION RULES PART 109) 2016

Under section 42 of the Civil Aviation Act 2008, the Minister for Communication and Aviation makes the following Rules –

Citation and commencement

1. These Rules may be cited as the Solomon Islands Civil Aviation Rules Part 109 2016 and come into force on the 31st day of September 2016.

Adoption of New Zealand Civil Aviation Rules Part 109 2. The New Zealand Civil Aviation Rules Part 109 (currently available on www.caa.govt.nz) under the heading of "Regulated Air Cargo Agent – Certification' is adopted as Solomon Islands Civil Aviation Rules Part 109.

Rule adoption statement & Interpretation Statement 3. The Rule adoption statement and the Interpretation Statement are set out in the Schedule.

Solomon Islands Civil Aviation Rules Part 109

Regulated Air Cargo Agent – Certification

Adoption Statement

This Part may be cited as Solomon Islands Civil Aviation Rule Part 109 comprises an adoption of the New Zealand Civil Aviation Rules Part 109, as modified hereunder and which Rule Part shall be read subject to the following Interpretation Statement.

Interpretation Statement

- (i) Any words (including place names) and numbers (including section numbers of Solomon Islands Acts of Parliament) to be substituted
- 1. For "New Zealand" read "Solomon Islands';
- 2. "the Act" means the Civil Aviation Act 2008;
- 3. "Director" refers to the Director of Civil Aviation;
- 4. "Minister" refers to the Minister for the time being responsible for civil aviation in Solomon Islands;
- 5. For forms beginning with "CAA" read "CAASI";
- 6. For "section 9 of the Act" read "Section 56 of the Civil Aviation Act 2008"; and
- 7. For "section 77F" read "Section 58" of the Civil Aviation Act 2008.
- (ii) any part or parts of the adopted rule which shall not apply in Solomon Islands

(iii) any general or parts of the adopted rule which shall not apply in Solomon Islands

(iv) any additional provisions or requirements not found in the New Zealand Rule Part but which will apply in Solomon Islands.

All references to the following phrases in the New Zealand Civil Aviation Rules Part 109 must be substituted to read "commercial air transport operation" in accordance with Amendment 11 to Annex 17 of the Convention on International Civil Aviation:

- 1. "International passenger aircraft"
- 2. "International regular air transport passenger service"; or
- 3. "aircraft carrying passenger".
- (v) any amendment to, or repeal of, any ule previously adopted in accordance with the provisions and procedures of this section.

(vi) any forms to be used in Solomon Islands

CAASI 24109/01 – Regulated air cargo agent application and renewal/amendment

(vii) any equivalent documents to be substituted for documents referred to in the adopted rule part.
