**CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE) ACT(CAP 84)**

**CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE) (PRESIDENT OF COURT OF APPEAL) (AMENDMENT) REGULATIONS 2020**

I, Hon. Manasseh Damukana Sogavare, the Prime Minister, under section 3 of the *Constitutional Offices (Terms and Conditions of Service) Act (Cap 84)*, make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Constitutional Offices (Terms and Conditions of Service) (President of Court of Appeal) (Amendment) Regulations 2020*.

**2 Commencement**

These Regulations commence on the day they are published in the Gazette.

**3. Amendment of *Constitutional Offices (Terms and Conditions of Service) (President of Court of Appeal) Regulations 2015***

These Regulations amend the *Constitutional Offices (Terms and Conditions*

of Service) (*President of Court of Appeal Regulations 2015* (Legal Notice 70 of 2015) (“**Principal Regulations**”).

#### 4. **Regulation 4 amended (Professional fees)**

Regulation 4 of the Principal Regulations is amended by:

- (a) inserting in paragraph (b) “if the President is in Solomon Islands for sittings of the Court,” before “a daily”; and
- (b) omitting from paragraph (c) “Chief Justice.” and substituting “Chief Justice;”; and
- (c) adding after paragraph (c):
- “(d) if the President is not in Solomon Islands for sittings of the Court but participates remotely in the hearing of an appeal or another court proceeding relating to an appeal:
  - (i) a fee of US\$1250 for each day the President so participates for more than 4 hours; or
  - (ii) a fee of US\$625 for each day the President so participates for 4 hours or less;
- (e) if the President is not in Solomon Islands for sittings of the Court but participates remotely by considering an appeal or other proceeding relating to an appeal on the papers:
  - (i) a fee of US\$1250 for each day the President so participates for more than 4 hours; or
  - (ii) a fee of US\$625 for each day the President so participates for 4 hours or less.”.

REGULATIONS 2020**

I, Hon. Manasseh Damukana Sogavare, the Prime Minister, under section 3 of the *Constitutional Offices (Terms and Conditions of Service) Act (Cap 84)*, make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Constitutional Offices (Terms and Conditions of Service) (Judges of Court of Appeal) (Amendment) Regulations 2020*.

**2 Commencement**

These Regulations commence on the day on which they are published in the Gazette.

**3 Amendment of *Constitutional Offices (Terms and Conditions of Service) (Judges of Court of Appeal) Regulations 2015***

These Regulations amend the *Constitutional Offices (Terms and Conditions of Service) (Judges of Court of Appeal) Regulations 2015* (Legal Notice 71 of 2015) (“Principal Regulations”).

**4 Regulation 4 amended (Professional fees)**

Regulation 4 of the Principal Regulations is amended by:

- (a) inserting in paragraph (b) “if the Judge is in Solomon Islands for sittings of the Court,” before “a daily”; and
- (b) omitting from paragraph (c) “Chief Justice.” and substituting “Chief Justice;”; and
- (c) adding after paragraph (c):
  - “(d) if the Judge is not in Solomon Islands for sittings of the Court but participates remotely in the hearing of an appeal or another court

proceeding relating to an appeal:

- (i) a fee of US\$1 000 for each day the Judge so participates for more than 4 hours; or
  - (ii) a fee of US\$500 for each day the Judge so participates for 4 hours or less;
- (e) if the Judge is not in Solomon Islands for sittings of the Court but participates remotely by considering an appeal or other proceeding relating to an appeal on the papers:
- (i) a fee of US\$1 000 for each day the Judge so participates for more than 4 hours; or
  - (ii) a fee of US\$500 for each day the Judge so participates for 4 hours or less.”.
