**EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 63) ORDER 2021**

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 63) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the Gazette.

**3 Non-citizens who may enter Solomon Islands**

- (1) Each of the following persons, who are delivering a new Twin Otter aircraft for Solomon Airlines and are due to arrive in Solomon Islands on 8 February 2021, may enter Solomon Islands to deliver that aircraft despite the prohibition under regulation 7(1) of the Regulations:

- (a) Daniel Gordon Irvin;
- (b) Anthony Scott Tripp.

**4 Expiry**

This Order expires on 11 February 2021.

**EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020**

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM  
QUARANTINE PERIOD)(NO. 30) ORDER 2021**

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 9 of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice 193 of 2020), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 30) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the Gazette.

**3 Exemption from quarantine period**

- (1) Each of the following persons, due to enter Solomon Islands on 8 February 2021 to deliver a new aircraft for Solomon Airlines, is on entering Solomon Islands exempted from being quarantined at a quarantine station for the quarantine period:
  - (a) Daniel Gordon Irvin;
  - (b) Anthony Scott Tripp.
- (2) The exemption under subparagraph (1) are subject to the condition that each person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
  - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
