**AN ACT**  
**TO AMEND THE FUEL SALES TAX ACT**  
**(Capter 72)**

[24th June, 1992]

BE IT ENACTED by the King and the Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1. (1) This Act may be cited as the Fuel Sales Tax (Amendment) Act 1992.
- (2) The Fuel Sales Tax Act (Cap. 72) is in this Act referred to as the Principal Act.
2. Section 4 of the Principal Act is hereby amended by:
  - (a) deleting "Treasurer" and replacing it with "Collector of Customs"; and
  - (b) deleting paragraph (a) and replacing it with the following paragraph (a):

"(a) upon importation; and".

3. Section 5 of the Principal Act is hereby amended by deleting the word "Treasurer" and replacing it with the words "Collector of Customs".

'OKU TU'UTU'UNI 'e he Tu'i mo e Fale Alea 'o Tonga 'i he Fakataha Alea 'a e Pule'anga 'o pehe:

1. (1) 'E ala ui 'a e Lao ni ko e Lao (Fakatonutonu) ki he Tukuhaui Fakatau Lolo 1992.

(2) Ko e Lao ki he Tukuhaui Fakatau Lolo (Vahe 72) 'i hono fakatonutonu, 'oku ui ia 'i he Lao ni, ko e tefito'i Lao.

2. 'Oku fakatonutonu 'a e Kupu 4 'o e Tefito'i Lao 'aki hono:

(a) tamate'i 'o e "Tauhi Pa'anga" pea fetongi'aki 'a e "Pule Tute"; pea

(b) tamate'i 'a e Palakalafi (a) pea fetongi'aki 'a e Palakalafi (a):

"(a) 'i hono fakahu mai; pea"

3. 'Oku fakatonutonu 'a e Kupu 5 'o e Tefito'i Lao 'aki 'a hono tamate'i 'a e lea "Tauhi Pa'anga" pea fetongi'aki 'a e lea "Pule Tute".
