NOTES TO THE ACCOUNTS.

1. Statement of Accounting Policies.

(a) Cash Basis.

The Accounts are prepared on a cash, with no adjustments made for accruals of revenue or expenditure.

(b) Valuation of Assets.

For Foreign Currency transactions were recorded at the Tonga Pa'anga equivalent effective at the date of transaction. The adjusting entry being the stating of any movement in exchange rates between balance dates being offset against the Exchange Revaluation Reserve.

2. Source of Income.

The primary source of income for the Trust was interest earned on the investments of the Trust Funds and the proceeds from the sale of Tonga Protected Persons Passports and Tonga National Passports and any revenue derived from other foreign sources as designated by His Majesty in Council.

3. Collections in Transit.

This items refers to some U.S. Bankdrafts which are still awaiting collection as at balance date.

4. Advances – Government of Tonga.

These items refer to transfers made to the Government of Tonga for development projects, namely, a further equity injection into Friendly Island Airways, \$2,098,835, the purchase of a Office Building for the London High Commission, \$1,991,892 and \$250,000 for assistance to Tourism Marketing. These payments were authorised in accordance with the requirements of the Tonga Trust Fund Acts, Cap 112, s.7.

7. Grant to the Government of Tonga.

These items refer to transfers made to the Government of Tonga for development Projects namely Lupepau'u Airport VIP Lounge of T\$14,386, and to Government Development Fund of \$1,069,862. These Payments were authorized in accordance with the requirements of the Tonga Trust Fund Acts, Cap. 112.
