## CIVIL AVIATION ACT 1990 (Section 7) CIVIL AVIATION (AIRPORT PARKING CHARGE) REGULATIONS 2002

In exercise of the powers conferred by section 7 of the Civil Aviation Act 1990, the Minister of Civil Aviation, with the consent of the Cabinet, makes the following Regulations:

1. These Regulations may be cited as the Civil Aviation (Airport Parking Charge) Regulations 2002.
2. In these Regulations, unless the context otherwise requires –
  - "Airport" means the Fuá'amotu International Airport;
  - "card" means the parking card under Regulation 4;
  - "charge" means a charge prescribed in the Schedule;
  - "officer" means an officer appointed under section 4 of the Civil Aviation Act 1990; and
  - "parking area" includes staff, public, taxi, VIP parking areas or any other area designated by the Minister under regulation 3.
3. (1) The Minister shall by appropriate signs designate any area at the Airport as a parking area.
  - (2) No person shall park a vehicle anywhere at the airport other than a parking area unless authorised by the Minister.
4. (1) All drivers or owners of vehicles shall be issued with a parking card when they enter the parking area, and such card shall include the time and date of entry to the parking area.
  - (2) All drivers or owners of vehicles shall keep the card at all times whilst at the airport.
  - (3) All drivers or owners of vehicles shall show the card and pay the prescribed parking charge before leaving the parking area.
  - (4) All drivers or owners of vehicles who lose the card before payment shall pay the prescribed charge.

5. No person shall park a vehicle at the staff, taxi or VIP parking area without the written permission of the Minister.
6. The Minister may exempt in writing any classes of vehicle from paying the prescribed charges.
7. All airport parking charges collected in accordance with these Regulations shall be paid into General revenue.
8. Any driver or owner of a vehicle who knowingly fails to pay any charge imposed by or contravenes any provisions of these Regulations, commits an offence and shall be liable on conviction to a fine not exceeding \$200 or imprisonment for a period not exceeding 1 month or both.

### Civil Aviation (Airport Parking Charge) Regulations 2002

#### (Regulation 4)

#### Schedule

<b>Public Car Park</b>	<b>Charge</b>
1. Day 1	: \$1.00 charge for the first hour or part thereof : .50 seniti for each additional hour or part thereof : \$10.00 maximum for first 24 hours
2. Each Extra Day	: \$5.00 per day or part thereof
3. Lost Card	: \$10.00

## CIVIL AVIATION ACT 1990

### (Section 7)

#### Civil Aviation (Aerodromes and Licensing Charges) (Amendment) regulations 2002

In exercise of the powers conferred by section 7 of the Civil Aviation Act 1990, the Minister of Civil Aviation, with the consent of Cabinet, makes the following Regulations.

1. (1) These Regulations may be cited as the Civil Aviation (Aerodromes and Licensing Charges) (Amendment) Regulations 2002.
- (2) The Civil Aviation (Aerodromes and Licensing Charges) Regulations 1996, as amended, are in these Regulations referred to as the Principal Regulations.
2. The Principal Regulations are amended by inserting a new regulation after Regulation 18:
 

"18A. A fee of \$250 shall be payable for the issue, renewal or replacement of any licence, rating or approval and an application fee may be charged as from time to time published in the Gazette."
3. Regulation 19 of the Principal Regulations is amended by deleting "50" and "25" and replacing them with "100" and "50" respectively.
4. Regulation 23 of the Principal Regulations is amended by deleting "25" and replacing with "\$50" and in line 2 the words "or licence" are deleted.
5. The Principal Regulations are amended by inserting a new regulation after Regulation 24:

#### "AIRPORT IDENTITY CARD

25. (1) The Minister may issue Airport Identity Cards.
- (2) A fee of \$50 shall be payable for the issue or replacement of an Airport Identity Card.
- (3) The Airport Identity Card shall contain the following:
  - (i) Card Number;
  - (ii) Name, signature and photograph of the holder;
  - (iii) Occupation;

- (iv) Date of Issue and Expiry;
- (v) Issuing Authority; and
- (vi) Access Code."

## LAO FOLAU VAKAPUNA SIVILE 1990

(Kupu 7)

### NGAAHI TU'UTU'UNI KI HE FOLAU VAKAPUNA SIVILE (TOTONGI TAU'ANGA ME'ALELE 'I MALA'E VAKAPUNA) 2002

'I hono ngaue'aki 'o e ngaahi mafai 'oku tuku mai 'e he kupu 7 'o e Lao Folau Vakapuna Sivile 1990, ko e Minisita 'o e Folau Vakapuna Sivile, mo e ngofua mei he Kapineta, 'oku ne fai 'a e Ngaahi Tu'utu'uni ko 'eni:

1. 'E ui 'a e Ngaahi Tu'utu'uni ko 'eni' ko e Ngaahi Tu'utu'uni ki he Folau Vakapuna Sivile (Totongi Tau'anga Me'alele Mala'e Vakapuna) 2002.
2. 'I he Ngaahi Tu'utu'uni ko 'eni, tukukehe ka fiema'u ha toe 'uhinga kehe 'i hono tu'unga' -

"Mala'e Vakapuna" 'oku 'uhinga ki he Mala'e Vakapuna Fakavaha'apule'anga Fua'amotu;

"kaati" 'oku 'uhinga ki he kaati tau'anga me'alele 'i he Tu'utu'uni 4;

"totongi" 'oku 'uhinga ki he totongi 'oku tu'utu'uni 'i he Tepile;

"ofisa" 'oku 'uhinga ki ha 'ofisa kuo fokotu'u 'i he kupu 4 'o e Lao ki he Folau Vakapuna Sivile 1990; pea ko e

"feitu'u tau'anga me'alele" 'oku kau ki ai 'a e feitu'u tau'anga me'alele 'a e kau ngāue, kakai, taxi, kakai mahu'inga' (VIP) pe ko ha feitu'u kehe kuo vahe'i 'e he Minisita 'i he Tu'utu'uni 3.

3. (1) Kuo pau ki he Minisitā, ke ne vahe'i 'aki ha ngaahi faka'ilonga 'oku fe'unga' ha fa'ahinga feitu'u 'o e Mala'e Vakapuna ko ha feitu'u tau'anga me'alele.
- (2) Kuo pau ke 'ikai ngofua ke tau 'e ha taha ha me'alele 'i ha fa'ahinga feitu'u 'i he mala'e vakapuna' kehe mei he feitu'u tau'anga me'alele' tukukehe 'o ka fakangofua 'e he Minisitā.

4. (1) Kuo pau ke foaki atu ki he kau faka'uli pe kau ma'u me'alele kotoa pē ha kaati tau'anga 'i he taimi 'oku nau hū ai ki he feitu'u tau'anga me'alele', pea kuo pau ke hā 'i he kaati ko ia' 'a e 'aho mo e taimi hū ki he feitu'u tau'anga me'alele'.
  - (2) Kuo pau ke tauhi 'e he kau faka'uli pe kau ma'u me'alele kotoa pē 'a e kaati' 'i he taimi kotoa pē lolotonga 'oku nau 'i he mala'e vakapuna'.
  - (3) Kuo pau ki he kau faka'uli mo e kau ma'u me'alele kotoa pē ke nau fakahā 'a e kaati' mo totongi 'a e totongi tau'anga me'alele kuo tu'utu'uni' kimu'a pea toki mavahe mei he feitu'u tau'anga me'alele.
  - (4) Ko e kau faka'uli pe kau ma'u me'alele kotoa pē kuo mole 'enau kaati' kimu'a 'i hono totongi' kuo pau ke nau totongi 'a e totongi kuo tu'utu'uni'.
5. Kuo pau ke 'ikai ngofua ki ha taha ke ne tau ha me'alele 'i he feitu'u tau'anga me'alele 'a e kau ngaue, me'alele uta totongi', kakai mahu'inga' (VIP) ta'e tomu'a ma'u ha tohi fakangofua mei he Minisitā.
  6. 'E ngofua ke faka'atā 'e he Minisitā 'i ha tohi, ha fa'ahinga me'alele mei he totongi 'o e totongi kuo tu'utu'uni'.
  7. Kuo pau ke totongi 'a e totongi tau'anga me'alele kotoa pē 'oku tanaki 'i he Ngaahi Tu'utu'uni ni ki he Pa'anga Hū Mai Fakalukufua'.
  8. Ka 'i ai ha taha faka'uli pe ha taha ma'u me'alele te ne ta'e totongi 'i he 'ilo pau ha pa'anga kuo hilifaki 'e he pe te ne maumau'i ha tu'utu'uni 'i he Ngaahi Tu'utu'uni ko 'eni', 'oku ne fakahoko ha hia pea kuo pau 'e ala mo'ua 'i ha'ane halaia ki ha tautea pa'anga 'e 'ikai toe lahi hake 'i he \$200 pe ngaue popula ki he vaha'a taimi 'oku 'ikai laka hake 'i he mahina 'e taha pe fakatou'osi.

**Ngaahi Tu'utu'uni (Fakatonutonu) (Ngaahi Totongi Mala'e Vakapuna mo e Laiseni)  
ki he Folau Vakapuna Sivile 2002**

'I hono ngaue'aki 'o e ngaahi mafai 'oku tuku mai 'e he kupu 7 'o e Lao Folau Vakapuna Sivile 1990, ko e Minisita 'o e Folau Vakapuna Sivile, mo e ngofua mei he kapineti, 'oku ne fai 'a e Ngaahi Tu'utu'uni ko 'eni:

1. (1) 'E ui 'a e Ngaahi Tu'utu'uni ko 'eni ko e Ngaahi Tu'utu'uni (Fakatonutonu) (Ngaahi Totongi Mala'e Vakapuna mo e Laiseni) ki he Folau Vakapuna Sivile 2002.
- (2) 'Oku ui 'i he Tu'utu'uni ko 'eni' 'a e Ngaahi Tu'utu'uni ki he Folau Vakapuna Sivile (Ngaahi Totongi Mala'e Vakapuna mo e Laiseni) 1996, 'i hono fakatonutonu', ko e ngaahi tefito'i tu'utu'uni.
2. 'Oku fakatonutonu 'a e Ngaahi Tefito'i Tu'utu'uni 'aki hono fakahū atu 'a e tu'utu'uni fo'ou ko 'eni' hili 'a e tu'utu'uni 18:  
"18A. Kuo pau ke totongi 'a e \$250 ki hono foaki, fakafo'ou pe fetongi 'o ha fa'ahinga laiseni, tu'unga pe ha fakangofua pea 'e ngofua ke hilifaki ha totongi kole 'a ia 'e pulusi mei he taimi ki he taimi 'i he Kasete'."

3. 'Oku fakatonutonu 'a e tu'utu'uni 19 'o e Tefito'i Tu'utu'uni' 'aki hono tamate'i 'a e "50" mo e "25" pea fetongi'aki 'a e "100" mo e "50" 'i hona tu'unga takitaha.
4. 'Oku fakatonutonu 'a e tu'utu'uni 23 'o e Ngaahi Tefito'i Tu'utu'uni 'aki hono tamate'i 'a e "25" pea fetongi'aki 'a e "\$50" pea tamate'i 'a e fo'i lea "pe laiseni" 'i he laine hono ua.
5. 'Oku fakatonutonu 'a e Ngaahi Tefito'i Tu'utu'uni 'aki hono fakahū atu 'a e tu'utu'uni fo'ou ko 'eni' hili 'a e Tu'utu'uni 24:

**"NGAAHI KAATI FAKA'ILONGA MALA'E VAKAPUNA**

- 25 (1) 'E ngofua ke foaki 'e he Minisitā ha ngaahi Kaati Faka'ilonga Mala'e Vakapuna.
- (2) Kuo pau ke totongi 'a e \$50 ki hono foaki pe fetongi 'o ha Kaati Faka'ilonga Mala'e Vakapuna.
  - (3) Kuo pau ke hā 'i he Kaati Faka'ilonga Mala'e Vakapuna' 'a e ngaahi me'a ko 'eni':
    - (i) Fika 'o e Kaati;
    - (ii) Hingoa, fakamo'oni hingoa mo e lau'i tā 'o e taha 'oku 'o'ona';
    - (iii) Lakanga;
    - (iv) 'Aho na'e foaki ai mo e 'aho 'e ngata ai;
    - (v) Ma'u Mafai na'a ne foaki'; mo e
    - (vi) Fika faka'atā fakapulipuli'."
