'I HONO NGAUE'AKI 'o e ngaahi mafai 'oku foaki 'i he kupu 19(1) 'o e Lao ki he Pule'i 'o e Toutai 2002, 'oku tu'utu'uni ai heni 'e he Minisita 'oku ne tokanga'i 'a e toutai, 'i he loto ki ai 'a e Kapineti:

1. 'Oku 'i he tu'unga fakatu'utamaki 'a e tolonga 'o e to'o 'o e mokohunu ki he ngaahi taumu'a faka'ekonomika.
2. Kuo pau ke ta'ofi 'a hono to'o, ngaahi mo hu ki tu'apule'anga 'o e mokohunu mei he ngaahi 'otu motu 'o Tongatapu, Ha'apai mo Vava'u ki he ngaahi taumu'a fakakomesiale mo hono hu atu ki tu'apule'anga 'i he ta'u ni pea 'e toki vakai'i 'i he ta'u takitaha hili ia.
3. 'Oku 'ikai ngaue'aki 'a e Fanongonongo ni ki he ngaahi ngaue ki hono faama'i 'o e ika.
4. Kuo pau ke ngaue'aki 'a e Fanongonongo ni ka e 'oua kuo toe 'i ai ha Fanongonongo kehe 'a e Minisita.

NOTICE

FISHERIES MANAGEMENT ACT 2002

(Section 19(1))

IN EXERCISE of the powers conferred by section 19(1) of the Fisheries Management Act 2002, the Minister responsible for Fisheries, with the consent of Cabinet, hereby orders that:

1. The long term sustainable harvesting of sea cucumber for economic purposes is endangered.
2. Harvesting, processing and export of sea cucumber from the island groups of Tongatapu, Ha'apai and Vava'u for commercial and export purposes shall be held for this year and be reviewed each year thereafter.
3. This Notice does not apply to aquaculture development.
4. This Notice shall remain in effect until further Notice by the Minister.
