(b) By-elections need be held in the said Area Councils to fill the said vacancies in accordance with section 11 of the Decentralization Act No. 11 of 1980;

THEREFORE, IN EXERCISE of the power contained in section 6(2) of the Decentralization Act No. 11 of 1980 as amended, THE ELECTORAL COMMISSION HEREBY MAKES the following Order:

DATE OF ELECTION

1. The election of councillors to fill the four vacant seats of the Banks and Torres Local Government Council shall commence on the 29th of May, 1984.



THE ISLAND COURTS ACT NO. 10 OF 1983

WARRANT ESTABLISHING THE EFATE ISLAND COURT

I, Frederick George Cooke, Chief Justice of the Republic of Vanuatu, under and by virtue of the powers conferred upon me by section 1 of the Island Courts Act No. 10 of 1983, HEREBY ESTABLISH THE EFATE ISLAND COURT to exercise the jurisdiction conferred upon it by The Island Courts Act or by any other Act but subject to the following limitations:-

Territorial Jurisdictions

The territorial jurisdiction of the Efate Island Court shall extend to the boundaries of the Efate Local Government Council.

Limitation on Criminal Jurisdiction

The criminal jurisdiction of the Efate Island Court shall be limited to trying the offences specified hereunder:-

a) The following offences in the Penal Code

- s. 88 : insult to religion;
- s. 89 : disturbing a religious assembly;
- s. 97A : adultery;
- s. 107(a) : assault;
- s. 121 : abusive and threatening language;
- s. 125(a) : theft, where the value of the alleged stolen object (or objects) does not exceed VT. 24,000;
