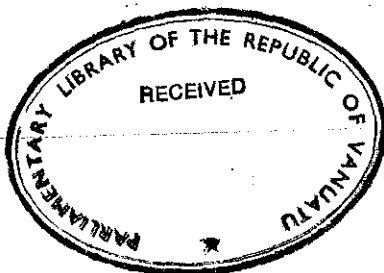

THE CIVIL AVIATION (AIRCRAFT SECURITY SERVICE FEES
REGULATION) ORDER No. 3 OF 1988

To prescribe the fees for providing security services for aircrafts landing at and departing from the Bauerfield Airport, Port Vila.

IN EXERCISE of the powers conferred by section 3(1)(r) of the Civil Aviation Act No. 38 of 1982, as amended, I hereby make the following Regulations:

SECURITY SERVICE FEES

1. Any aircraft landing at and departing from Bauerfield airport, Port Vila, on an international passenger flight for which security services is provided shall on its departure be charged, and shall pay a security service fee of 1.000 vatu.

FEES PAID TO DIRECTOR OF CIVIL AVIATION

2. (1) The fees herein provided shall become due and payable by the representative of the airline within one month of receipt of an invoice.
(2) The fees shall be paid to the Director of Civil Aviation in Port Vila.

FEES TO BE RECOVERED AS A CIVIL DEBT

3. If the representative of the airline fails to pay the fees to which the airline is liable under these Regulations, the Director of Civil Aviation may recover from the representative of the airline the said fees due as a civil debt together with costs.

COMMENCEMENT

4. These Regulations shall come into force on the date of their publication in the Gazette.

2. (1) Les droits mentionnés ci-après sont exigibles et doivent être payés par le représentant de la compagnie aérienne dans un délai d'un mois à compter du jour de réception de la facture.
- (2) Les droits sont payés au Directeur de l'Aviation Civile à Port-Vila.

RECOUVREMENT DES DROITS A TITRE DE DETTE CIVILE

3. Si le représentant de la Compagnie aérienne omet de payer les droits exigibles conformément aux présents règlements, le Directeur de l'Aviation Civile peut les recouvrer en tant que dette civile, augmentés des frais.

4. Les présents règlements entreront en vigueur le jour de leur publication au Journal Officiel.
