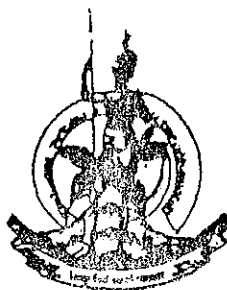

CHAPTER 49

TAXIS (INSPECTION OF PUBLIC VEHICLES FEES) ORDER NO. 6 OF 1991

An Order to prescribe the fees for inspection of public vehicles.

IN EXERCISE of the powers conferred by section 26 of the Taxis Act [CAP 49], I, EDWARD N NATAPEI, Minister of Public Works, Communications, Transport, Ports and Marine, make the following order :-

INSPECTION FEE

1. (1) Every vehicle in respect of which an application for a public vehicle licence or the renewal thereof is made under section 9 (1) of the Taxis Act [CAP 49] shall be charged and paid in respect of the inspection of such vehicle a fee at the following rates :-
 - (a) for inspection on application for a public vehicle licence VT3,000;
 - (b) for inspection on application for the renewal of a public vehicle licence VT3,000;
 - (c) for the issue of a certificate of Mechanical Fitness VT 500.
- (2) Any fee referred to in subsection (1) payable on the grant of a public vehicle licence or the renewal of the public vehicle licence in respect of the inspection of the vehicle or the issue of the certificate of Mechanical Fitness in respect of such vehicle shall be paid before the applicant is granted a licence, renewal or certificate of Mechanical Fitness.
- (3) Any fee payable under this Order shall be paid to the Director of Public Works or an officer at the Public Works Department authorized, in writing, in that behalf by the Director.

COMMENCEMENT

2. This Order shall come into force on the day of its publication in the Gazette.

ARRETE

DROIT DE VISITE TECHNIQUE

1. 1) Tout véhicule de transport en commun pour lequel on présente une demande d'autorisation d'exploitation ou de renouvellement sous l'autorité du paragraphe 1) (article 9) de l'arrêté conjoint No. 36 de 1966 fera l'objet du paiement d'un droit de visite technique aux taux suivants :

- a) pour l'autorisation d'exploiter un véhicule de transport en commun 3.000 VT ;
- b) pour le renouvellement de l'autorisation d'exploiter un véhicule de transport en commun 3.000 VT ;
- c) pour la délivrance d'un certificat de bon état de marche 500 VT.

2) ~~Le droit visé au paragraphe 1) ci-dessus exigible pour la visite technique d'un véhicule ou pour la délivrance d'un certificat de bon état de marche doit être acquitté avant l'octroi d'une autorisation d'exploiter un véhicule de transport en commun, de son renouvellement ou avant la délivrance dudit certificat de bon état de marche.~~

- 3) Tout droit exigible sous l'autorité du présent arrêté est acquitté au Directeur du Service des Travaux publics ou à son agent habilité par écrit.
