THE FORESTRY REGULATIONS (AMENDMENT)
ORDER NO. 27 OF 1993

To amend the Forestry (Regulations) Order No. 10 of 1984.

IN EXERCISE of the powers conferred by section 34 of the Forestry Act [Cap.147], I, **ONNEYN MORRIS TAHI**, Minister of Agriculture, Livestock, Forestry and Fisheries, hereby make the following Order:-

AMENDMENT OF THE FORESTRY (REGULATIONS) ORDER NO. 10 OF 1984.


1. The Forestry (Regulations) Order No. 10 of 1984, as amended, is further amended in regulation 5 by inserting after paragraph (k) the following new paragraph -

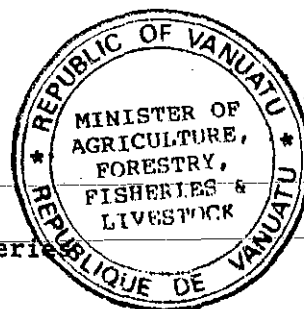
"(kA) the licensee shall pay to the Minister a timber licence fee of 2,500,000 vatu upon the granting of a timber licence, and an annual fee of 1,500,000 vatu upon the renewal of a timber licence;"

CHAPTER 147

FORESTRY (BAN ON THE EXPLOITATION OF WHITE-WOOD
ON EFATE) ORDER NO. 23 OF 1993

An Order to ban the exploitation of white-wood (*endospermum medullosum*) on the island of Efate.

IN EXERCISE of the powers conferred by section 34(2)(f) of the Forestry Act [CAP 147], I, **ONNEYN MORRIS TAHI**, Minister of Agriculture, Livestock, Forestry and Fisheries, hereby make the following Order:-

BAN OF THE EXPLOITATION OF ENDOSPERMUM MEDULLOSUM ON EFATE


1. (1) The exploitation of the species of tree technically known as *endospermum medullosum* or otherwise commonly known as white-wood is hereby prohibited for a period of 10 years commencing from the date of the publication of this Order in the Gazette.

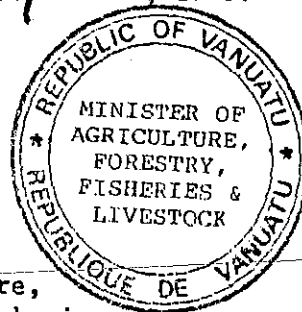
- (2) Any person who contravenes or fails to comply with subsection (1) of this Order shall be guilty of an offence punishable by a fine not exceeding VT 50,000.
