## CHAPTER 182

### MINIMUM WAGE AND MINIMUM WAGES BOARD (AMENDMENT) ORDER No. 5 OF 1995

To increase the minimum rate of wage within and outside the municipal boundaries.

IN EXERCISE of the powers conferred upon me by section 3(1), I, CHARLIE NAKO, Minister of Home Affairs, make the following regulation: -

#### AMENDMENT OF REGULATION 2 OF ORDER NO. 56 OF 1987

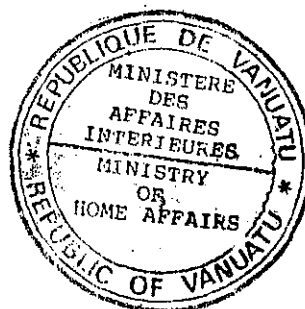
1. Regulation 2 of the Minimum Wage and Minimum Wages Board (Regulations) Order No. 56 of 1987 is amended -
  - (a) in subregulation (1) by deleting the figure "13,200" and substituting the figure "16,000";
  - (b) in subregulation (2) by deleting the figure "11,440" and substituting the figure "16,000".

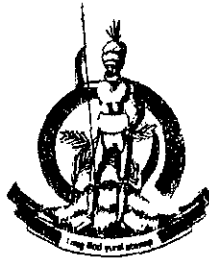
#### COMMENCEMENT

2. This Regulation shall come into force on the first day of March, 1995.
