The following persons are appointed as members of the Vanuatu Maritime Authority:

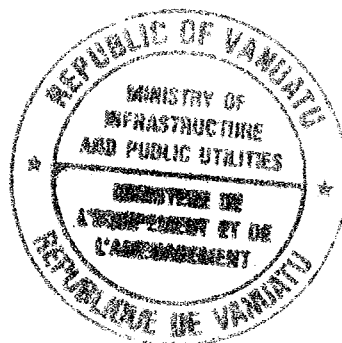
- (a) Christopher Emelee being a person with experience in international maritime law;
