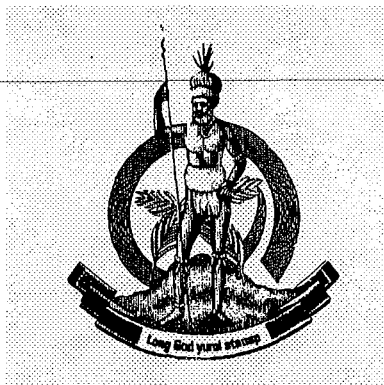

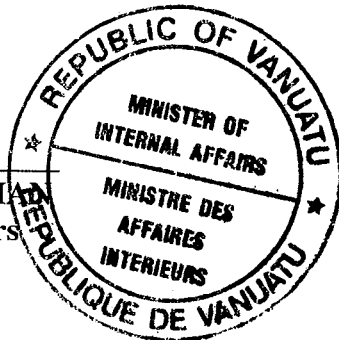
- (a) Chief Daniel Golow, nominated by the representative bodies of Chiefs;
