

1 Amendments

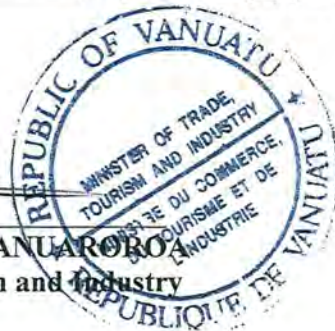
The Trademarks for Goods and Services (Fees) Regulation Order No. 15 of 2012 is amended as set out in the Schedule.
